TREASURER'S REPORT:

- Steve reported that UICS has a good surplus.
- Steve reported that expenditures are where they need to be, 58% through the FY.

ACTION ITEMS:

- 1. Approved January minutes.
 - a. Steve corrects two amounts from January Treasurer's Report:
 - i. Surplus should be \$777,838
 - ii. The three categories of deferred revenue should total \$385,804, not \$392,000.
 - b. Bill Motioned, Wanda Seconded, Motion passed unanimously
- 2. Approved Land Trust
 - a. Wanda Motioned, Doug Seconded, Motion passed unanimously

- Committee discussed assurance measures with Prasad, which included a list of 26 financial reports he prepares, an RFP for an independent auditor going out soon and internal controls, which Bill suggested reviewing.

- Angie reports faculty and staff will begin receiving 2nd vaccine this week

 - Steve informs that a minimal reserve should be 1 month of operating costs, which equates to close to \$230,000 in the school's case
 - Auditor's suggest 2 months is better and 3 months is the best situation, which would be close to \$700,000
- Further discussion of what to do with amount exceeding the 3 month operating cost reserve
 - Bonuses for faculty and staff
 - o Replacing carpet on East side of building
 - Student bathroom renovations
- Decision to vote on faculty and staff bonuses as well as carpet replacement at March meeting
